Following clearing cycles shall be followed where the drawee bank has a centralized clearing arrangement i.e. a designated online branch / center within the city.

04:30pm	Before the close of next business day

SAME DAY OUTWARD CLEARING (CENTRALIZED) For All Instruments type of amount Rs. 100,000/- & above.		
Collection at Branches	Availability of funds in Customer Account	
09:30am	After 4:00pm and before the close of the same business day.	
<u>Note</u> : Cheques received from customer after 09:30 am shall be processed in Normal outward clearing.		
INTERCITY OUTWARD CLEARING ( CENTRALIZED)		
Collection at Branches	Availability of funds in Customer Account	
04:30pm	Before the close of next business day	
Note: Cheques received from customer after the cutoff time of 04:30pm shall be lodged in the batch of next business day

## CLEARING TIMING (REMOTE AREAS)

For remotes areas where NiFT services are not available or the drawee branch does not have an online designated branch, following timings shall be followed for direct arrangements between branches:

NORMAL OUTWARD CLEARING:		
Collection at Designated Branches	Availability of funds in Customer Account	
	<ul> <li>In case drawee branch is having an online designated branch in the area, the funds shall be made available <u>before the close of the next</u> <u>business day</u>.</li> </ul>	
04:30pm	<ul> <li>In case drawee bank is not located in the region &amp; the funds are realized through nearest other city's designated online branch, the funds shall be made available on the third business day from the lodgment date (t+2 basis).</li> </ul>	
	<ul> <li>In case drawee's bank only has an offline designated branch in the same city / area, the funds shall be made available <u>before the close of</u> <u>the next business day as per prevailing</u> <u>mechanism</u>.</li> </ul>	
Note: Cheques received from customer after the cutoff time of 04:30pm shall be lodged in the batch of next business day
